Feedback

- Illustrated Paper Session: Enjoyed illustrated paper session & we should continue to emphasize this next year; we should do an illustrated paper award and need a judge (Jennifer Rahn agrees to help coordinate/judge); this award is already in the by-laws; we just need judges and implementation
- Student paper competition: Tom asked if the procedure for organizing the student award session worked out OK?; according to students it worked out OK; For some new students didn't receive the information; If you are not a member; Tom will try to figure out if AAG can self identify on the registration process?; Could possibly keep it on the facebook page. Paul-If you are a new member is there a way that you can told or link to the webpage from AAG; Prompt new member to goto website of specialty group. ***; it will be proposed in the business meeting tomorrow. Next to the name of the specialty group have a hyperlink; can we have a MS and PhD award for physical and human side; in case we don't have enough of each, maybe we can do a second place; there is discretion in the bylaws that we can have an undergraduate award but we don't have it written that we need to do (could be a human/physical or grad/undergrad distinction); many times MS papers are better than Ph.D. so we don't necessarily need to separate them; students need to be students at the time of submission (they could have graduated); Paul-maybe we need to have a certain number and a \$ amount of awards and leave it up to the discretion of the judges to figure it out; we may not have enough student members according to Tom; Tom-lets entertain an amendment to the bylaws next year; Tom-lets keep the status quo for awhile and make a motion later on to distinguish Ph.D. to masters; Could we up the student paper award?; We are going to keep it for now; There is also some concern about not having the student paper = to the formal presentations; Paul, maybe we will name some of the awards after Robin or others?
